- SJNBA Constitution rule change – Allow 25% of bowlers in league to be Non-Nisei. With all leagues reporting amendment has passed. Rule change will be in effect for 2007-2008 bowling season. Marc will make changes to electronic copy of SJNBA Constitution and have ready for distribution.
- NCNBF expulsion update
 - Marc met with Greg Gong, current President of Federation who said that the letter was not supposed to be an expulsion letter. Marc presented a list of demands for SJ to return to Fed. Mainly to not pay dues this year. Also, be accountable for financial reports, where does the money go? Summarization of benefits to bowlers, etc.
